Over the last decade Old Town has experienced several community planning issues, each of which touch upon a common theme: regional circulation planning. The regional circulation aspect is the consequence of the momentous Destination Lindbergh plan. This plan envisions the airport's buildout with all support facilities, air freight, passenger processing functions, parking, and intermodal access to be re-located to the Pacific Highway side of Lindbergh Field near Washington Street.

To accommodate the increased traffic from the projected buildout Destination Lindbergh incorporates expanded freeway access onto the North-South Interstate 5 freeway; but, it does not incorporate capacity plans for its equally necessary expanded freeway access onto the East-West Interstate 8. Destination Lindbergh leaves the planning of this circulation access to be solved by SANDAG and The City of San Diego. In this respect the plan is incomplete.

With increasing clarity It appears that the circulation planners at SANDAG and the City have selected an in-house solution for the airport's East-West regional circulation needs. They have apparently decided to not modify the I-5 to I-8 interchange to accommodate the regional increased traffic from Lindbergh. This increase is expected to be 4.4 million cars per year on Pacific Highway. The total number is really much higher. Instead they seem to be planning a connector ramp through Old Town between Pacific Highway and I-8 along the Taylor Street right of way.

Major flaws with such a connector ramp include the destruction of the 1769 Birthplace of California and negative impacts to Presidio Park and the San Diego Presidio National Historic Monument. Such a connector would destroy the site of Kosa'aay (Cosoy), the 1769 Kumeyaay village that saved the Portola expedition from starvation. Kosa'aay was also the site of the first

Amerindian organized opposition to European military colonization in what became the U. S. Frontier. That reason alone should make Kosa'aay dear to all freedom loving Americans. The pedestrian zoned streetscape of Taylor Street would be severely impacted; and, the already overburdened parking in the Pacific Highway trolley lot would be greatly reduced.

In this regard the boundary of the Old Town Business Improvement District is of interest. This boundary goes outside the Old Town Community Planning District footprint and delineates a corridor up Palm Canyon connecting Taylor Street to Hickory Street at Presidio Drive. The existence of a proposed route into Mission Hills from Taylor Street may indicate that the connector ramp solution could disrupt, if not prevent, Juan Street access into Mission Hills. Thus the impacts of using Taylor Street for the regional traffic appear to be at the expense of Mission Hills and Old Town's historic resources, economic future, and pedestrian oriented environment.

We have asked the SANDAG representatives if they are planning such a Taylor Street connector ramp, but they will not confirm or deny it. Neither SANDAG, nor the City, have had public discussion about this regional transportation issue. Instead they appear to be hiding the connector ramp within the "The 2050 Circulation Plan" and disguising its implementation as mitigations of unrelated projects.

SANDAG's planning is required to promote Sustainable Communities but a Taylor Street connector ramp would severely reduce the economic viability of Old Town and destroy its primary historic resource, the 1769 Birthplace of California. The apparent East-West solution benefits Destination Lindbergh at the expense of the surrounding communities. We do not believe that the SANDAG Directors would knowingly allow this to happen.

Therefore prior to the release of the mid-coast trolley extension draft EIR we ask SANDAG and the City to conduct a public workshop and study. The scope of this workshop/study should be regional transportation issues including 1) The interaction of the Mid-Coast Trolley and the Taylor Street at-grade crossing and 2) For the East-West circulation demand generated by Destination Lindbergh buildout a regional solution that is holistic and works for everyone involved.




