Old Town Chamber of Commerce

The Old Town San Diego Chamber of Commerce includes over 485 members governed by 12 volunteer Board of Director members (elected by the general membership) including 2 part-time employees. The Old Town Chamber of Commerce is a member of the San Diego Business Improvement District Alliance. The Old Town Chamber manages the Old Town Business Improvement District and Old Town Parking District.

Each year the Old Town Chamber of Commerce holds a Board Retreat. Thank you to the Hacienda Hotel in Old Town for hosting the Chamber retreat for the FY2019. Below are the goals set for the fiscal year by the Old Town Chamber of Commerce Board of Directors.

Event Recap

During FY 2019 Old Town Chamber of Commerce hosted 3 events earning \$21,225.36 in revenue for OTSD programs. 2019 was the year that the Old Town Chamber of Commerce decided to expand the traditional Dia de los Muertos procession to include market on San Diego Avenue. This acted as a fundraiser for the Chamber. The Old Town Chamber of Commerce was able to organically reach over 631k people on social media with their Facebook event for Dia de los Muertos, which was a promotional milestone.

President's Message

The Old Town San Diego Chamber of Commerce (OTSD) is a nonprofit 501(c)6 organization that contracts with the City of San Diego as a Business Improvement District. OTSD was designed with the mission to: Develop and promote commercial opportunities for our businesses while enhancing a positive experience for the entire Old Town community.

OTSD has several committees that meet on a regular basis. The Organization Committee, Design Committee, Promotions Committee and Parking Committee. Each committee has responsibilities that help to keep Old Town vibrant, safe and visitor friendly.

Each year the Board of Directors meets to develop goals for the Fiscal Year. In 2019 the board decided to; use technology to promote Old Town, build cooperation between all stakeholders in Old Town and to enhance the El Camino Real Trail. This year OTSD has developed a significant following on social media including a reach of 631K for the Día de los Muertos event post. Old Town also grew the direct email database by 1200 email addresses. The OTSD Safe and Clean committee has been meeting regularly and OTSD formed a new Old Town Lodging Committee to build relationships with the local hotels. Volunteers were able to work on the El Camino Real Trail by upgrading the landscaping and ensuring that the trails was safe for visitors. A sign was also placed at the bottom of the trail to help link Old Town with Presidio Park.

Another exciting development has been our outreach and partnering with the Kumeyaay Nation as we look forward to 2020 when the Old Town State Historic Park expands for the first time in forty years to celebrate the history and the culture of our first people, the Kumeyaay.

OTSD has entered into FY2020 with new goals to pursue every opportunity for grant funding, create silent auction baskets for promoting Old Town, more participation in State Park events including looking for funding sources, to assist HOTCF with organizational challenges and more emphasis on Safe & Clean initiatives.
